1. Local artists must be a resident of Coronado, work a minimum of 20 hours per week in Coronado or , own property in Coronado.
2. All artwork must be original and the work of the registered applicant only, and completed in the last four years. Artists may not share their space with another artist unless prior arrangements have been.
3. No commercial goods for resale or consigned goods will be allowed.
4. All artists must provide their own tables, chair, umbrella (w/base) and any and all other display equipment needed. Work may be hung, freestanding or able to be placed on your table. You will be allotted about an 8' x 10' space.
5. Artists are encouraged to include three digital images of your of work suitable for use in promotional materials.
6. Artists are required to collect and pay their own state sales tax.
